## FRANCHISE AGREEMENT

### 1. APPOINTMENT OF FRANCHISEE

The Franchisor hereby appoints the Franchisee as an **Authorized Franchise Partner** to conduct **Computer Education & Vocational Training Programs** under the name and authority of the NBCTE Board.

### 2. RIGHTS GRANTED

The Franchisee shall have the non-transferable right to:

- Use the **Brand Name, Logo, and Trademarks** of the Board/Institute strictly for authorized purposes.
- Conduct approved courses and training programs.
- Enrol students and collect fees as per guidelines.
- Issue certificates to successful candidates **only with NBCTE Head Office / Board approval.**

### 3. RESPONSIBILITIES OF FRANCHISEE

The Franchisee shall:

- Maintain proper infrastructure, faculty, and equipment as per Board standards.
- Abide by the **Syllabus, Fee Structure, and Examination Rules** provided by the NBCTE Board.
- Not engage in any fraudulent practices, misuse of certificates, or unauthorized courses.
- Maintain student records and submit reports to the **NBCTE Head Office.**

### 4. TERM & RENEWAL

## 5. FEES & REVENUE SHARING

The Franchisee agrees to pay:
